The Cultural Festival has the goal to promote the artistic production, with various styles and share a little of your path and creativity, to professionals or amateurs, it is a place open to the public at Espaço do Sarau.

There will be available to subscription productions, unprecedented or not, in audiovisual media and/or in person on different artistic expressions, such as: theater play, poetry, narrative, humor, music, photography, video or short/feature films, in Brazilian Sign Language (Libras) and/or International Signs (IS)

I. Approving Criterions

The evaluation of the performances will be done according to the artistic expression category and based in the following criterions:

- I.I Selection criteria for deaf artists
- a) Creativity, originality and quality of artistic production.
- b) Fluent in Pounds and/or International Signs (SI)
- **I.II** Selection criteria for listening artists.

In this case that item I is not included, perhaps, if there was one available in the space, for artists who listen:

- a) Creativity, originality, quality of artistic production.
- b) Presentation in Pounds and/or International Signs (SI)
- c) In hearing artistic groups, there must be at least one deaf participant.

Note: The Deaflympics Cultural Center will not provide Sign Language Translators and Interpreters during presentations, if necessary, the proponent will be responsible.

II. Selecting Communication

- a) We will send an email to the selected artists. Approved artists will have three days to respond to confirmation of participation. After this period, they will be deleted.
- b) We will send an email to the non-selected artists and there will be no appeal of the committee's decision.







III. Cultural Festival Regulations

Presentations may be in person and/or audiovisual, with duration depending on the modality:

III.I In-person:

III.I.I Narrative, humor and poetry: with a minimum duration of 03 minutes and a maximum of 30 minutes.

III.I.II Theater and Performance, with a minimum duration of 10 minutes and a maximum of 60 minutes.

III.I.III Photographs, with exposure time agreed later after approval in this public notice.

III.II Audiovisuals:

III.II.I Short film and video: with a minimum duration of 10 minutes and a maximum of 45 minutes, with the credits of the work.

III.II.II Feature film, film and video, with a maximum duration of 1h20 minutes, with the credits of the work. (To be arranged, if schedules are available at the cultural center).

The. In items 1.1 and 1.2, the artistic presentation video (trailer) and/or audiovisual (trailer) must be sent in advance, sent as an attachment in the registration process.

III.III The registration form must contain the description and photocopy (photo) of the material(s) to be presented at the Sarau, sent by attachment to the registration.

III.IV The Cultural Space will be open to the public, whether in person, online and/or recordings with partners from the 24th Summer Deaflympics, Caxias do Sul-RS, Brazil.

III.V The order of presentations will be defined until April 20, 2022. They will be modified if the cultural space commission has this need and it is previously agreed with the approved artists.

III.VI In cases of delays by participants or groups, their presentations will be transferred to other periods, to be agreed.

III.VII The in-person and/or audiovisual artists/groups will need to have the author/s and credits of the works, leaving the copyright free and authorized for the execution of the works at the 24th Deaflympics in Caxias do Sul-RS and project: Arte de Signal.

III.VIII Presentations, whether in any expression, characterized with content considered obscene and/or sexual, devaluation, prejudice, whether ethnic or of any kind, will not be accepted and are prohibited. Nude performances on stage, political-partisan and religious broadcast/propaganda will not be allowed.

III.IX No awards, no competition, no cache or other provision of financial resources from 24th Deaflympics and partners. The participants who will present during the event at the Cultural Center are volunteers.

III.X All technical and personal demands, namely: equipment, objects, scenarios, lighting, props, travel costs, food, accommodation or the need for other professionals involved (such as musicians or technicians) to comply with this notice, are the responsibility of the tenderer/participant.

III.XI Light and sound will be unique and standardized for everyone.

III.XII Animals will not be allowed on stage, use of water and fire, or flammable materials.
